Availability: Proweld® equipment is available for rental to authorized distributors only. Please allow up to 5 days from receipt of order confirmation to prepare and ship rental equipment. Please note availability is not guaranteed.

New Orders: Purchase orders must include start date and expected duration. Each new order requires a signed rental agreement prior to equipment shipment confirming price and selection.

Rental Billing: Billing starts when the tool is delivered and ends the day the tool arrives at our dock. Charges are processed monthly and billed according to quoted rental rates.

Daily: Calendar Day (includes weekends + holidays)

Rental minimums: All SP high purity, EF 110-B, and Industrial Tools 14" (355mm) and above will rent at a 5-day minimum.

Freight: Insured transportation on all outgoing and incoming rental equipment must be provided by the distributor. Equipment may be combined with other shipments to reduce overall cost. If outgoing shipment is freight allowed, Asahi will only charge for additional insurance if not already covered. Please inspect delivered equipment for damage upon receipt from the freight company. Failure to identify freight damage will transfer liability from the freight company to the distributor.

Consumables: All consumable items must be purchased. These items include (but are not limited to) printer labels and ribbon, beadless balloons, planer blades, heater bushings.

Warranty: Please call Asahi immediately if the equipment is not operating properly, Asahi warrants 6 month on-site usage. Routine maintenance is recommended after six months where equipment may be field serviced by Asahi authorized personnel or returned to Asahi. All freight and/or field service charges must be paid for by the distributor.

Jobsite Transfer: Equipment transfer between jobs is not recommended. Written approval must be given by Asahi and a new signed rental agreement must be completed. No warranty can be provided for equipment not originating from Asahi's facility.

Returning Rental Equipment: Please contact the Rental Department to request a Return Material Authorization (RMA) prior to shipping.

Damage: An initial evaluation upon return will identify any abnormal damage. Equipment requiring excessive cleaning and/or repair will be billed at current shop labor rates. Broken or missing components will be billed at current replacement costs. Customers may be billed for the entire cost of replacement machine if returned equipment is unrepairable.
